BOARD OF COMMISSIONERS

RESOLUTION

WHEREAS, the Board of Commissioners of Hospital Service District No.1 of Tangipahoa Parish, recognizes the need for certain hospital administration officers to have the ability to transact business, on behalf of the Board, the Board resolves as follows:

As of January 1, 2017, President/Chief Executive Officer, Michele K. Sutton shall be, and is hereby, designated authorized agent for North Oaks Health System and all its affiliated entities (collectively "NOHS") with sole and exclusive authority [except to the extent outlined below] to bind NOHS to any and all contractual, financial, and other operational commitments of whatever kind within the guidelines, policies, and other parameters set forth by the Board of Commissioners.

The Board authorizes the Chief Operations Officer, Michael Watkins, and Chief Financial Officer, Mark Anderson (or any person whom may succeed these individuals in such referenced executive positions) to execute contracts at the request of the CEO in her absence, and contracts thereby executed shall be effective and binding on NOHS as if executed by the CEO.

NOHS policy requires no less than two authorized signatures on all checks issued by NOHS, and the Board hereby designates Ms. Sutton, Mr. Watkins, and Mr. Anderson as authorized persons to so sign NOHS checks.

Except as identified above, no other persons, whether previously designated as authorized or not, shall have authority to perform the referenced actions as an agent of NOHS.

To the extent legally required for a North Oaks Health System affiliated entity to carry out its business operations, the Board authorizes the authorized officers then in place with such affiliated entity to execute documents needed to transact the business of the entity,

To the extent not in conflict with the matters addressed herein or in conflict with guidelines, policies, and parameters set by the Board or established in law, the Board authorizes the CEO to authorize and delegate other leadership of NOHS to carry out necessary acts and functions consistent with the effective and efficient operations of NOHS.
